# MISSION

EU PPF Programme “EU Project Preparation Facility” represents technical assistance financed from the European Union pre-accession funds. The value of the programme is more than EUR 35.5 million, out of which EU donation equals to EUR 34.24 million while the Government of Republic of Serbia contribution is EUR 1.33 million.

The EU PPF aims to strengthen technical and administrative capacities of the administration of the Republic of Serbia with regard to the management and use of the EU pre-accession funds and other international financial assistance, in order to speed up preparations for EU membership.

## MANAGEMENT AND ORGANIZATION

The EU PPF is managed by the Delegation of the EU to the Republic of Serbia, Ministry of Finance – Department for Contracting and Financing of EU Funded Programmes (CFCU) and the Ministry of European Integration who is also the key beneficiary of the programme. Line Ministries that are also beneficiaries of the EU PPF are: Ministry of Agriculture, Forestry and Water Management (and its Water Directorate), Ministry of Environmental Protection, Ministry of Mining and Energy, Ministry of Construction, Transport and Infrastructure, Ministry of Labour, Employment, Veteran and Social Affairs, Ministry of Education, Science and Technological Development, Ministry of Public Administration and Local Self-Government, Ministry of Youth and Sport, Ministry of Finance, Ministry of Health, Ministry of Justice, Ministry of Economy and the Ministry of the Interior.

To carry out the main operational functions and ToR assignments of the EU PPF Programme, EUDEL, MEI and CFCU contracted a dedicated EU PPF team, which comprises of the following units:

2. EU PPF7 Unit
3. EU PPF8 Unit
4. EU PPF9 Unit
5. EU PPF10 Unit



## OBJECTIVES

- » Assistance to the Serbian administration to effectively manage the EU integration and pre-accession assistance;
- » Preparation of technical and tender documentation for infrastructure projects related to energy, environment, transport and social infrastructure sectors;
- » Organization of capacity building trainings for representatives of relevant local and national institutions and enhancement of their capacities;
- » Assistance in structural adjustment and update of the Document on Needs of the Republic of Serbia for International Assistance;
- » Assistance to the Ministry of EU Integration and the responsible line ministries in the programming of pre-accession funds to structure the foreign assistance requirements of the Republic of Serbia.

## RESULTS

### INFRASTRUCTURE PROJECTS

With the assistance provided through the EU PPF programme, the necessary documentation for 15 major projects in the field of transport, energy, environment and social infrastructure is under preparation.

### CAPACITY ENHANCEMENT/TRAININGS
